GENERAL TERMS & CONDITIONS FOR PURCHASE ORDER

1. Scope of Work

2. Price & Payment Terms

- The price mentioned in the PO is fixed and inclusive of all applicable taxes, duties, and charges unless stated otherwise.
- Payment will be made within 7 days from the date of invoice submission, subject to satisfactory delivery and inspection.
- Any discrepancies in the invoice may result in payment delays.

3. Delivery & Timelines

- Delivery shall be made at the designated site within 7days.
- Any delay in delivery may result in penalties (2% per week) or cancellation of the PO at our discretion.
- The vendor shall notify the company in writing of any potential delays and seek approval for revised timelines.

4. Quality & Inspection

- All materials/services must meet the required quality standards and specifications.
- The company reserves the right to inspect, test, and reject any substandard materials/services.
- Rejected items must be replaced at the vendor's cost within 7 days.

5. Warranties & Defects

- The vendor warrants that the goods/services shall be free from defects, functional,
- and fit for purpose for a minimum period of 12 months from the delivery date.
- Any defects arising during this period shall be rectified/replaced by the vendor at no additional cost.

6. Indemnity & Liability

The vendor shall indemnify the company against any claims, damages, or losses arising due to defective goods/services, non-compliance, or negligence.

7. Compliance with Laws

The vendor shall comply with all applicable local laws, regulations, and safety norms related to labor,

taxation, and environmental standards.

8. Termination & Cancellation

- The company reserves the right to cancel the PO, with or without cause, by giving 7 days' notice.
- In case of non-compliance, poor performance, or breach of terms, the company may terminate the PO with immediate effect.

Neither party shall be held liable for delays or non-performance due to unforeseen events beyond reasonable control (e.g., natural disasters, strikes, government actions).

10. Jurisdiction & Dispute Resolution

- Any disputes arising shall be resolved amicably. If unresolved, they shall be subject to the jurisdiction of courts in Indore (M.P.). 11. The vendor should provide door delivery for the carpet
- 12. The vendor will provide the plastic cover on the carpet after installation.
- 13. Deep Cleaning/Vacuum cleaning to be done before final handover.
